A Message from Register Iannella

If you are filing a motion, complaint or other action here in the Probate and Family Court, **it is up to you — not the court —** to notify every other person involved in the case. With very few exceptions, nothing proceeds until all parties have been properly notified. This is called '*service of process.*'

When you file a case with the court, the *summons* and a copy of the *complaint* must be served to the other parties in the case. This can be done by a Deputy Sheriff or Constable. While they charge a fee for their services, they know exactly what must be done to legally serve other parties in your case, and will work quickly to get a signed *Return of Service* back to you. You are required to file this receipt with the court. This is proof that the other parties in the case have been properly notified. Without it, your case may not go forward.

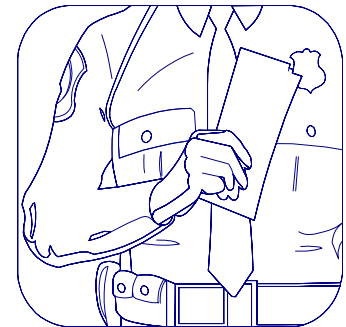

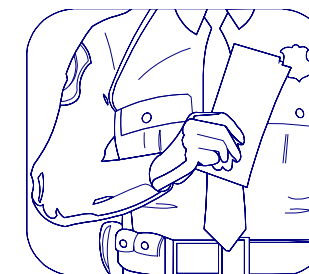
